**ORDER**

Provisional affiliation was granted to start MBA programme at Monti International Institute of Management Studies (Unaided), Puthanangadi (PO), Angadippuram, Malappuram with an intake of 50 seats for the academic year 2015-16, vide U.O read as 1<sup>st</sup>. above .

2. Permanent increase of 10 seats was granted to MBA programme at the college from the academic year 2018-19 vide U.O read as 2<sup>nd</sup> above.

3.Continuation of Provisional Affiliation was granted to MBA programme(60 intake) for the academic year 2021-22, vide the U.O read as 4<sup>th</sup> above on conditional basis subject to the submission of renewal NOC from Government of Kerala for the year 2021-22.

4. The Principal has submitted necessary documents along with the application which have been insisted in the U.O. and Circular read as 3<sup>rd</sup> & 5<sup>th</sup> .

5. The Principal, Monti International Institute of Management Studies (Unaided), Puthanangadi (PO), Angadippuram, Malappuram has applied for Continuation of Provisional Affiliation to MBA Programme for the academic year 2022-23 vide paper read as 6<sup>th</sup> above . An amount of Rs.1,32,300/- ( Rupees One Lakh Thirty Two Thousand Three Hundred Only) has been remitted by the college towards Administration & Affiliation fee vide chalan No.212555372 dated 17.12.2021.

6. AICTE has extended its approval to the MBA programme for the academic year 2022-23 with the intake of 60 students at Monti International Institute of Management Studies (Unaided), Puthanangadi, Angadippuram, Malappuram, vide paper read as 7<sup>th</sup> above.

7. Vide G.O read as 8<sup>th</sup> , the Department of Higher Education, Govt. of Kerala has renewed the NOC for conducting MBA Course with 60 seats at Monti International Institute of Management Studies (Unaided), Puthanangadi, Angadippuram, Malappuram for the academic year 2021-22.

8. Considering the above, Sanction has been accorded by the Vice Chancellor on 24.07.2022 for

granting Continuation of Provisional Affiliation to MBA programme with an intake of 60 seats at Monti International Institute of Management Studies (Unaided), Puthanangadi, Angadippuram, Malappuram for the academic year 2022-23, on conditional basis subject to the submission of renewal NOC from the Government of Kerala for the academic year 2022-23 and making the U.O read as 4<sup>th</sup> as absolute, since the College has produced renewal NOC from the Government for the academic year 2021-22.

**9. Following orders are, therefore, issued.**

**i) Continuation of Provisional Affiliation is granted to the MBA programme with 60 seats at Monti International Institute of Management Studies (Unaided), Puthanangadi, Angadippuram, Malappuram for the academic year 2022-23, on conditional basis subject to the submission of renewal NOC from Government for the academic year 2022-23.**

**ii) Continuation of Provisional Affiliation granted to MBA programme conditionally during 2021-22, vide U.O. read as 4<sup>th</sup> is thus made absolute.**

10. Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for the continuation of provisional affiliation for the ensuing years by remitting the fee fixed by the University, along with a copy of extension of approval from the apex body concerned.

11. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the University.

12. The Controller of Examinations shall ensure that examinations are not conducted in the colleges without having valid affiliation orders.

13. The conduct of University Examinations of any sort, including that of S.D.E Examinations, is compulsory and binding on all colleges affiliated to the University of Calicut.

14. In the light of the direction of the Hon'ble Supreme Court of India in WP(C) 656/1998 the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action, including withdrawal of affiliation of the college will be initiated.
